Committee reviewed the Reliance Fire Company election results.

Committee reviewed RFP Submission Sheet for 2023.

Kelsey Mitchell reviewed budget documents she provided Committee. Early next year Committee will have more budget discussion, but for starters Kelsey Mitchell would like to know what type of increase Committee would like to do for employees as a starting point for the budget. Crevino suggested 3.5% as a starting point, on the high side and then adjustments can be made based off other figures in the budget, if needed.

Mayor Eachus briefly discussed a shared service with Woodstown for construction services, but Committee agreed right now is not a good time to make any changes with the upcoming warehouses.

Motion made by Bonowski, 2nd by Crevino to open the public comment. Ayes all.

James Steward from 22 Fox Road asked for clarification on what is changing in the pool ordinance. Committee responded with the only changes being made are in regards to ladders on above ground pools and fences on above ground pools.

Mr. Steward also wanted to know what warehouses are being built. Mayor Eachus stated there are warehouses being built on the sod farm across from the Fairgrounds on Route 40. This area is the only area in Pilesgrove zoned for this use at this time.

Hearing no other comments motion made by Crevino, 2nd by Eachus to close the public comment. Ayes all.

Motion made by Eachus, 2nd by Bonowski to enter into closed session to discuss matter accordance with NJSA 10:4-12, specifically contract negotiations. Ayes all.

Motion made by Bonowski, 2nd by Crevino to enter into open session. Ayes all.

Bonowski brought up Glenn Albertson who recently passed away. Glenn Albertson has been a major asset to the Marlton Park Recreation Committee for years and Committee would like to do a resolution naming the 50/70 field after him on opening day. Township Clerk will start working on this resolution and Bonowski will contact Glenn's wife to let her know what Committee would like to do.
